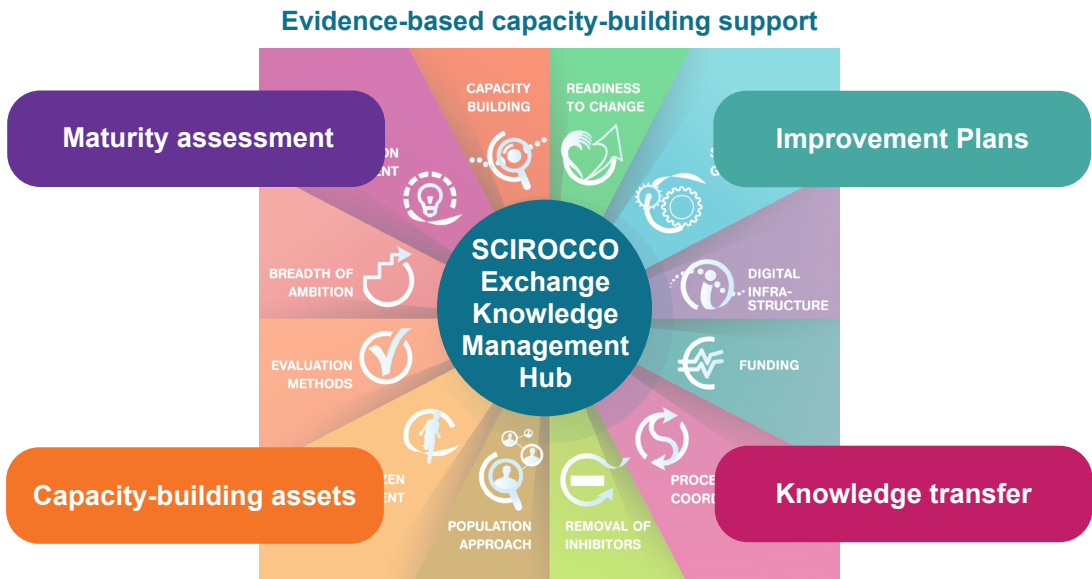

About the project

The SCIROCCO Exchange project builds on the preliminary achievements of the B3 Action Group on Integrated Care (of the European Innovation Partnership on Active and Healthy Ageing). The group first developed the concept of the B3 Maturity Model. Through the activities of the EU Health Programme funded project SCIROCCO, the Model has been further refined and tested. It is now supported by a validated online self-assessment tool for integrated care.

Goals

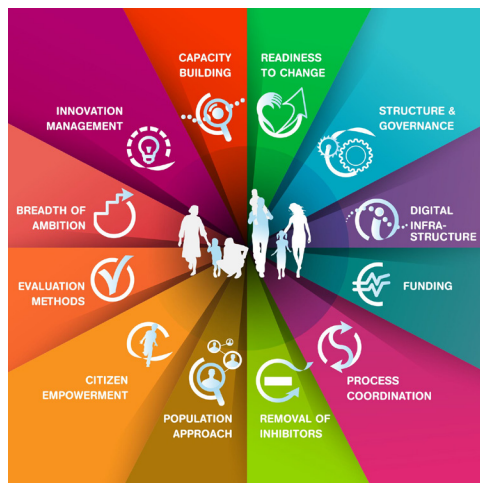
The SCIROCCO Exchange project aims to support health and social care authorities in the adoption and scaling-up of integrated care.



The ambition of the project is to maximise the value and impact of the SCIROCCO tool for regions and organisations involved in the deployment of integrated care by:

- **Developing a Knowledge Management Hub** to act as an integrator and facilitator for accessing personalised learning and capacity-building support for integrated care.
- **Co-designing personalised support** for those seeking support to prepare the ground for transition and/or improve existing system design for integrated care.

- **Facilitating understanding of local readiness**, needs and priorities for the adoption and scaling-up of integrated care.
- **Utilising outcomes of knowledge transfer and capacity-building** activities to co-design improvement planning that is tailored to the local context, maturity and aspirations of European regions and organisations.

About SCIROCCO Exchange

SCIROCCO Exchange is a 32 month project, running from January 2019 to August 2021. The project's total budget is €2,649,587. The project consortium consists of 14 partners from 10 countries, including national and regional healthcare authorities, universities, competence centres and membership organisations. Capacity-building support will be provided to 9 national and regional healthcare authorities, with diverse maturity and organisation of integrated care.
